# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF AJN DA GAMA FAMILY LLC

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the Members, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of AJN DA GAMA FAMILY LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on August 25, 2016, and assigned document number 1.16000158886, and contirms that these Amended and Restated Articles of Organization bereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

#### ARTICLE I. NAME
