**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the Members, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of DGVA HOLDINGS LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on August 25, 2016, and assigned document number L16000158894, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

**ARTICLE I. NAME**

The name of the limited liability company is DGVA HOLDINGS LLC (the "Company").

**ARTICLE II. ADDRESS**

The purpose of the Company is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


**ARTICLE VII. ADDITIONAL MEMBERS**
