

ARTICLES OF ORGANIZATION

OF

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Revised Florida Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name and street address of the registered agent of the Company in the State of Florida and principal office is:




