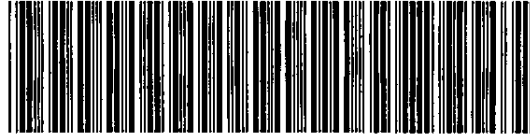

ARTICLE I

- Name -

The name of the Limited Liability Company is YJ2 BUCKEYE, LLC.

- Address -
