**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 605.0707 of the Florida Limited Liability Company Act, as amended, the undersigned limited liability company adopts the following Articles of Dissolution for the purpose of dissolving the limited liability company:

1. The name of the limited liability company is Florida Oral and Maxillofacial Surgery of Bradenton, LLC (the "Company").
2. The Articles of Organization of the Company were filed on August 26, 2016, and assigned document number L16000160089.
3. The effective date of the Company's dissolution is the date these Articles of Dissolution are filed with the Florida Department of State.
