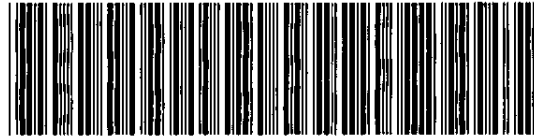

Registered Agent and Office

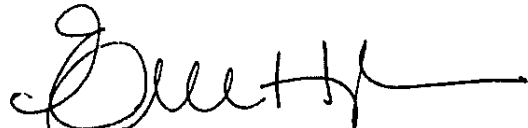

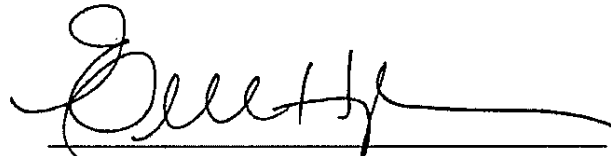
