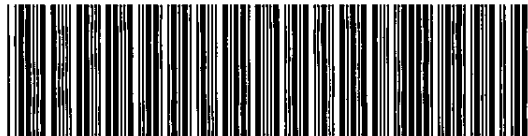

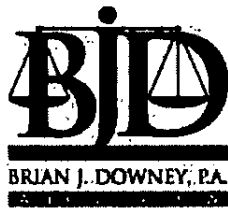

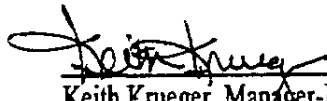

1. Name. The name of this limited liability company is LAWN RESCUE OF SWFL, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including lawn maintenance and treatment services and such other lawful activities as are reasonably necessary, convenient or incidental to this purpose.
4. Place of Business. The mailing and street address of the Company's principal office is 939 Altadena Road, Fort Myers, Florida 33919.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Keith Krueger. The street address of the initial registered agent of the Company is 939 Altadena Road, Fort Myers, Florida 33919.
6. Additional Members. Additional members to the Company may be admitted as provided for in the Company's Operating Agreement.
7. Management of the Company. The Company shall be managed by its managers, in accordance with the Regulations adopted by all of the members. The name and address of the manager is:

8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.
9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
10. Members' Rights. Pursuant to section 605.04074 of the Florida Statutes, no member of the Company other than the managers shall be an agent of the company solely by virtue of being a member, and no member other than the managers shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member. Any Operating Agreement of the company as defined in section

605.0102(45) of the Florida Statutes must be in writing and signed by all the initial members.
