**ARTICLES OF ORGANIZATION
OF
FOR ALL MANKIND, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the Limited Liability Company shall be **FOR ALL MANKIND, LLC**. (“Company”).

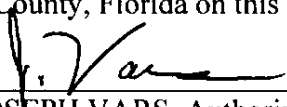
ARTICLE X – TERMINATION OF EXISTENCE
