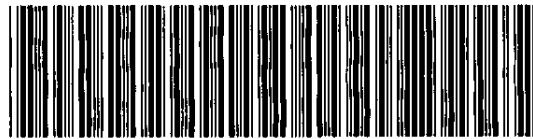

The initial registered agent for this Company shall be Erica H. Sterling and the address of the registered agent for service of process shall be 500 Fleming Street, Key West, FL 33040.




