**ARTICLES OF ORGANIZATION
OF
PREMIER EMPLOYMENT GROUP, LLC**

The undersigned, J. Garrett McNeil, a natural person competent to contract and an authorized representative of Premier Employment Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of Premier Employment Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Premier Employment Group, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 10343 East Highway 30A, Suite 105, Seacrest Beach, FL 32413. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS


ARTICLE VI - MANAGEMENT


