ARTICLES OF ORGANIZATION OF JPM AA HOUSING, LLC

ARTICLE I

The name of the Limited Liability Company is JPM AA Housing, LLC (the "Company").

ARTICLE II

The mailing address and street address of the principal office of the Company is 401 Commerce Street, Suite 800, Nashville, Tennessee 37219.

ARTICLE III

The transfer by such trustee, receiver, executor, administrator, committee, guardian or conservator of any Company interest shall be subject to all of the restrictions hereunder to which such transfer would have been subject if such transfer had been made by such bankrupt, deceased, dissolved, liquidated, terminated or incompetent member.

ARTICLE IX

The Company shall indemnify each member, manager and officer of the Company and any other person who has acted on behalf of the Company to the maximum extent provided by the Act.

No member, manager or officer of the Company shall have any fiduciary or other duty to any creditor or claimant of the Company at any time.
