**ARTICLE IV - MANAGEMENT**

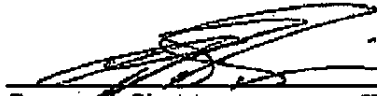

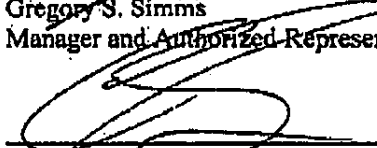
**ARTICLE V - ADDITIONAL PROVISIONS**
