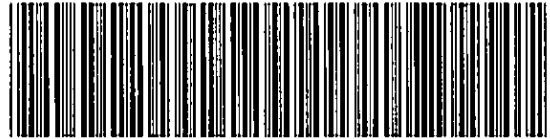


The parties both declare:
