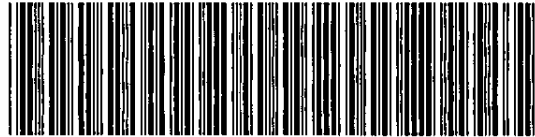


ARTICLE I - Name
