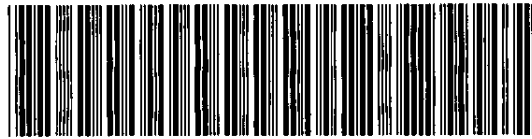


ARTICLE IV


