AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BAM RESIDENTIAL HOLDINGS, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of BAM Investment Group, LLC, originally filed on September 9, 2016, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME
