**ARTICLES OF ORGANIZATION
OF
BOXTOWN BRITE LITE, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is BOXTOWN BRITE LITE, LLC.

ARTICLE II - ADDRESS

The address of the principal office and the mailing address of the Company is 5300 Shad Road, Jacksonville, FL 32257.

ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE IV - MANAGEMENT OF THE COMPANY


