ARTICLES OF ORGANIZATION

OF

KINGS OF RECOVERY, LLC

a Florida Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes §605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be KINGS OF RECOVERY, LLC ("Company").

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the principal office of the company shall be 14010 SE 41st Court, Summerfield, Florida 34491 and the mailing address of the company shall be 14010 SE 41st Court, Summerfield, Florida 34491.

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. ARTICLE VI - TERMINATION OF EXISTENCE - MEMBER'S RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy, dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the Company unless the business of the Company is continued by the consent of all remaining members, provided there is at least one remaining member.
