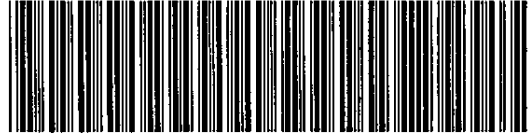




On July 25, I mailed Articles of Organization for two proposed Florida LLCs, **Buck Kelly LLC** and Buck Kelly Ventures LLC, to the Florida Division of Corporations. Both submissions were in the same envelop and contained separate \$125.⁰⁰ filing fees. Apparently, you processed my initial request on August 8, but rejected both filings for improper signatures. A short time later, I received both rejected filings in the mail (in the same envelope) with instructions to correct the documents and return them with your rejection letters. On August 20, I mailed corrected Articles for both entities, along with your instruction letters, in the same envelope, back to your offices.

Apparently, you processed the re-submission(s) on August 24, 2016. However, only Buck Kelly Ventures LLC got activated (see document # L16000157885.) **Buck Kelly LLC** is still showing as rejected (see document # **W16000054577**.) Furthermore, I no longer have your "Instruction Letter" as it was included in the revised submission, which appears, at least partly, to have been lost somewhere in your organization.

Per today's telephone instructions from your office, I am re-submitting the revised Articles of Organization for **Buck Kelly LLC** (attached) without the required Rejection Instruction Letter, and instead referring you to **W16000054577**.


