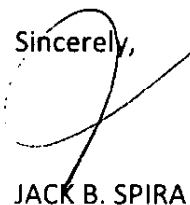

**ARTICLES OF ORGANIZATION
OF
REBECCA NOVO, PLLC.**

The undersigned persons hereby adopt these Articles of Organization in order to form a professional limited liability company under Chapter 605 of the Florida Statutes.

ARTICLE I – NAME

The name of this limited liability company shall be REBECCA NOVO, PLLC. (the “Company”).
