MANAGEMENT**

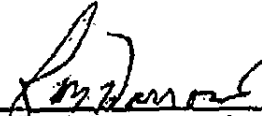

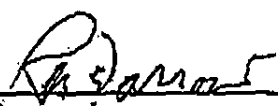
