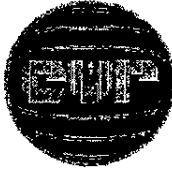

My name is Talbot J Simons. I am the owner of the formerly incorporated "Electro Visual Revolution - worldwide, inc." I received an email a few days ago regarding this situation.

Since our incorporation in 2014 we really didn't do anything with the inc version of this company. At this time the document has been administratively dissolved.

Due to a number of reasons - my team and I have decided to transition to an LLC for tax and liability reasons. Our secretary apparently never filed follow up paperwork as requested - as such - the document number has been dissolved. We never did any business under this name up until this point - and we are notifying the IRS of the situation for EIN purposes.

We are trying to relist ourselves as an LLC, but we have been requested to submit this formal letter in order to release the "Electro Visual Revolution - worldwide" name to be used as an LLC instead.
