**ARTICLES OF ORGANIZATION OF
NESTLE ENTERPRISES, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the Organizers of Nestle Enterprises, LLC under the Florida Revised Limited Liability Company Act (the "Act"), Chapter 605, Florida Statutes, adopt the following Articles of Organization.

**Article I
Name**

The name of the limited liability company is Nestle Enterprises, LLC (the "Company").

**Article II
Period of Duration**

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company will be perpetual.

**Article III
Purposes, Powers and Capital Contributions**

- A. Purposes. The Company is organized for, and may engage in, any lawful purposes.
- B. Powers. The Company may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 605, Florida Statutes as the same may be amended from time to time.
- C. Capital Contributions. The Members will make contributions from time to time, as required by the Operating Agreement adopted by the Company.

**Article IV
Member-Managed Limited Liability Company**

The overall management and control of the business and affairs of the Company is vested in its members, as provided in these Articles of Organization and section 605.0407 of the Act. Any and all action by the Company will require the vote of members holding a majority interest in the Company.

Persons Authorized to Manage and Control the Limited Liability Company

These articles shall be effective upon filing.

Article VII

Article IX
Initial Members

Initially the Company will have two members. The Company will always have at least one member and it may admit additional members upon the agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

Article X
Continuity of Business

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or on the occurrence of any other event that terminates the continued membership of a Member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all remaining Members of the Company.

Article XI
Indemnification

Except as expressly provided in the Operating Agreement, the Company shall indemnify any Member, manager, or former Member or manager to the full extent permitted under the Act.

Article XII
Adoption of Operating Agreement

The Company will adopt an Operating Agreement for the Company, which may contain provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 605, Florida Statutes.

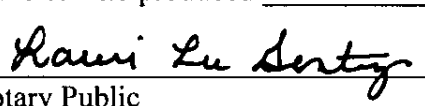

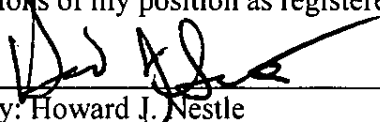
