**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is NW 98th Terrace LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The Company shall be manager-managed. The initial Manager of the Company will be Jeanette Wilson, 156 NW 98th Terrace, Plantation, Florida 33324.




