ARTICLES OF ORGANIZATION OF ZN HOME INVESTMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be ZN HOME INVESTMENT, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 7255 NW 68TH Street, Suite 10, Miami, Florida 33166 and the mailing address shall be the same.
