

**ARTICLES OF ORGANIZATION
OF
CANTERBURY #2288, L. L.C.**

These Articles of Organization of Canterbury #2288, L.L.C., are being duly executed and filed to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes. (the "Act").

ARTICLE I

Name

The name of the limited liability company (the "**Company**") formed hereby is:

CANTERBURY #2288, L.L.C.

ARTICLE II

Address of Principal Office

The mailing and street address of the Company's principal place of business in the State of Florida is 36750 US Highway 19 North, Palm Harbor, Florida 34684.

ARTICLE III

Date of Existence and Duration

The period of duration of the Company shall begin on the date hereof and continue perpetually.

ARTICLE IV

Address of Registered Office

The address of the initial registered office of the Company is 36750 US Highway 19 North, Palm Harbor, Florida 34684, and the name of its initial registered agent at such address is Peter Hyde.

ARTICLE V

Management

The Company will be managed by a board of directors (the "**Board of Directors**") who shall act as Managers pursuant to the Act. Subject to any restrictions imposed by law of the Regulations of the Company, the Board of Directors may exercise all of the powers of a Manager under the Act. Any action by the Board of Directors shall be deemed to be an action by the Managers of the Company for the purposes of the Act or otherwise. The name and address of each initial Member

of the Board of Directors of the Company (who shall serve until the initial meeting of the Members of the Company, or until such time as such director's successor is elected or appointed and qualified, or, if earlier, until such director's death, resignation, or removal from office) is/are as follows:

ARTICLE VI

Admission of Additional Members

New Members may be admitted to the Company only with the unanimous consent of the Board of Directors. A newly admitted Member will execute all documents necessary to complete the admission, including but not limited to a written acceptance and adoption by the New Member of the provisions of these Articles of Organization, and such other documents as necessary to reflect the admission of the New Member. Any New Member will be entitled to all of the same rights and privileges as the original Member. The terms of such admission and the capital contributions of any newly admitted members will be determined by the existing Members.

ARTICLE VII

Members' Rights to Continue Business

In the event there is more than one Member, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, the surviving and/or remaining Member(s) shall have the right to continue the Company or to terminate and liquidate the Company.




