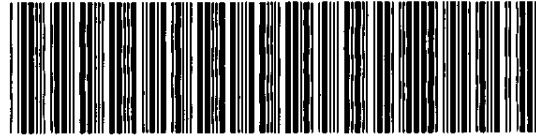

ARTICLES OF ORGANIZATION  
OF  
VASALAKIS AND ASSOCIATES, LLC

1. Name. The name of this limited liability company is VASALAKIS AND ASSOCIATES, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of September 29, 2016 and shall thereafter be perpetual.
