**ARTICLES OF ORGANIZATION  
FOR

The undersigned, for the purposes of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I - NAME.**

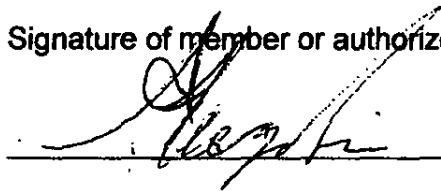
