ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
AQUILA SURGICAL MANAGEMENT, LLC

The undersigned being the Manager and Authorized Representative of Aquila Surgical Management, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Aquila Surgical Management, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective October 4, 2016.
3. Article 1 of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE 1.
NAME

"The name of the Limited Liability Company shall be Aquila Surgical Partners, LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.

5. These Articles of Amendment have been approved by unanimous Written Action of the Members dated October 24, 2016, which vote is sufficient for approval.

6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
