Myntti, Ph.D., a natural person competent to contract and an authorized representative of Next Science Wound Care, LLC, hereby presents these Articles of Organization as the Articles of Organization of Next Science Wound Care, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Next Science Wound Care, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS
