
**ARTICLE VII

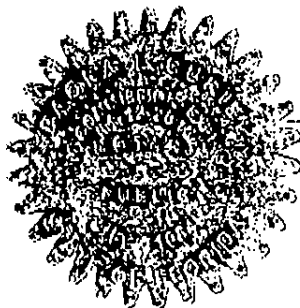
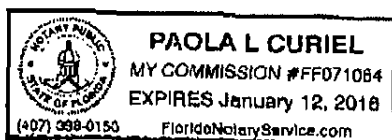
