The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, hereby certifies:

**ARTICLE I - NAME**

The name of the limited liability company shall be V & Z BEAUTY SALONS LLC, hereinafter referred to as the "Company".

**ARTICLE II - ADDRESS**

The principal street address and mailing address of the Company 600 NE 27<sup>TH</sup> Street, Unit LPH-5, Miami, Florida 33137.

**ARTICLE III - PURPOSE**

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

**ARTICLE IV – MANAGEMENT**

The Company shall be managed by one or more managers and is a manager-managed Company. The initial managers of the Company shall be Sean Zahniser and Mauricio Valencia. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

The Registered Agent of the Company shall be Sean Zahniser. The address of the Registered Office is 600 NE 27<sup>TH</sup> Street, Unit LPH-5, Miami, Florida 33137. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 605 F.S. regarding the same.

**ARTICLE VI – OWNERS**

The initial member(s) of the Company shall be:

Sean Zahniser (50% Membership Interest) – 600 NE 27<sup>TH</sup> Street, Unit LPH-5, Miami, Florida 33137.

Mauricio Valencia (50% Membership Interest) – 5050 Biscayne Blvd., Miami, Florida 33137.

Members of the Company may be added or removed, from time to time, as provided by law or in the Company's Operating Agreement.

#### ARTICLE VII – DURATION


