#### ARTICLE I.

The name of the Limited Liability Company is "Advantage Machining Service, LLC" (the "Company").

#### ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company is 5320 NW 19th Place, Ocala, Florida 34482.

#### ARTICLE III. DURATION
