3. Orlando Arias is authorized to conduct all necessary actions under the statements above.

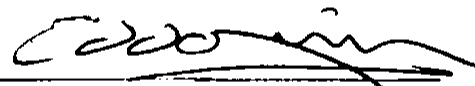

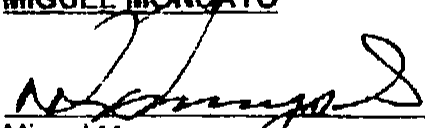

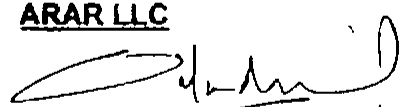
