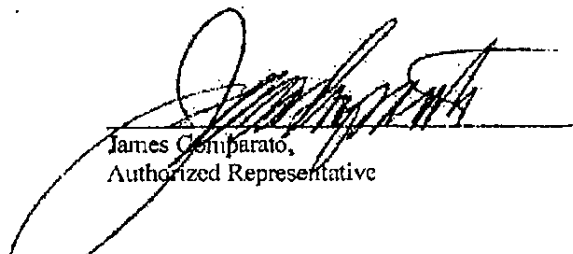
ARTICLE IV
