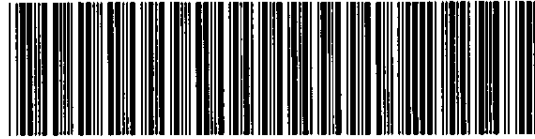

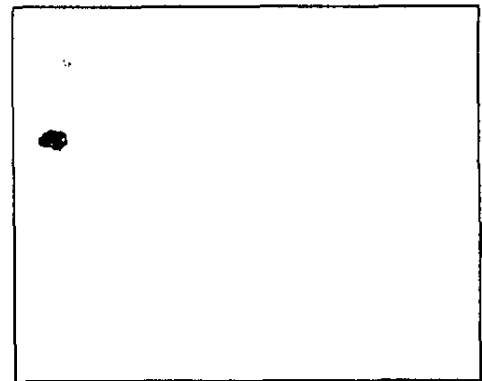

NAME**
