

ARTICLES OF ORGANIZATION

REGENTSEA TRAVEL, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **REGENTSEA TRAVEL**, **LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 88005 Overseas Highway, #10-165, Islamorada, Florida 33036 and the mailing address shall be the same.
