ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be "JTM INVESTMENT HOLDINGS, J.T.C." ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 111 N. Orange Avenue, Suite 900, Orlando, Florida 32801.

ARTICLE III




