1. The Articles of Organization of the Company are hereby amended to change and correct the name of the Manager mistakenly reflected as Rob Stevenson to the following:

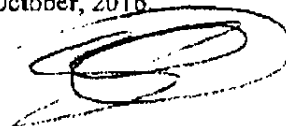
