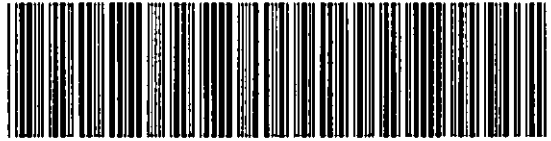

FIRST: The Articles of Organization for the Company were filed on October 20, 2016 and assigned Florida Document number L16000193713.


SECOND: The Company desires to amend Article III in its entirety and the following shall be in its stead:
