

## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF CAROL BUCK HOLDINGS, LLC

These Articles of Amendment to Articles of Organization of Carol Buck Holdings, LLC, a Florida limited liability company (the "Company"), is submitted in accordance with Section 605.0202, Florida Statutes, as follows:
