Williams, a natural person competent to contract and an authorized representative of Tango Three Coffee Company, LLC, hereby presents these Articles of Organization as the Articles of Organization of Tango Three Coffee Company, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**
