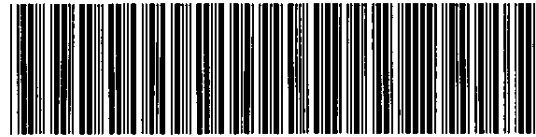

**ARTICLES OF ORGANIZATION

MANAGEMENT OF THE COMPANY**




