**ARTICLES OF ORGANIZATION FOR
FISCHER GRAHAM FAMILY, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 605 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be **FISCHER GRAHAM FAMILY, LLC**
2. Duration/Continuation. The period of this company's duration shall be perpetual unless terminated by the unanimous written agreement of all members.
3. Address. The mailing and street address of the company is **2750 NW 137th Place, Reddick, FL 32686**.

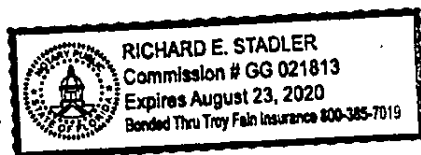
