
**ARTICLE VII


**ARTICLE VIII

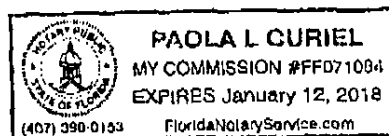
