### ARTICLES OF ORGANIZATION

### OF

THESE ARTICLES OF AMENDMENT to Articles of Organization of C&C REALTY REFERRAL, LLC, a Florida limited liability company (the "Company"), are submitted in accordance with § 605.0202 of the Florida Revised Limited Liability Company Act.
