## ARTICLES OF ORGANIZATION OF 178 WALNUT MOUNTAIN, LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

#### ARTICLE I NAME

The name of said limited liability company shall be:

178 Walnut Mountain, LLC

#### ARTICLE II TERM

178 Walnut Mountain, LLC shall exist in perpetuity.

#### ARTICLE III PRINCIPAL OFFICE
