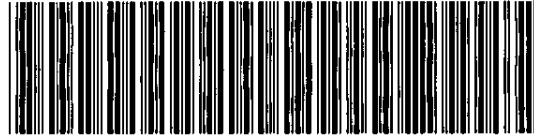

Registered Agent**

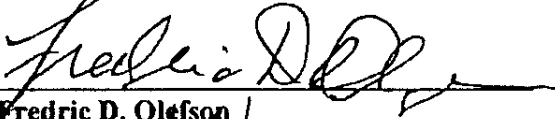
