Principal Office

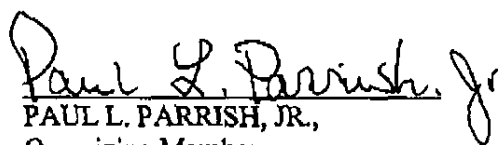
The street address of the principal office of the Company shall be 3629 Avenida Madera, Bradenton, Florida 34210, and the mailing address shall be the same.

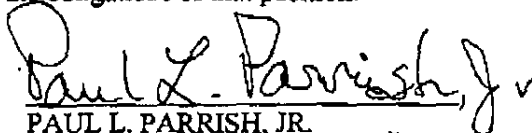
