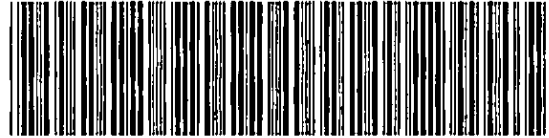

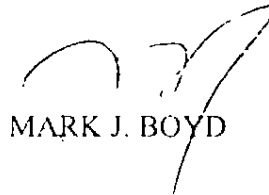

**ARTICLE I - NAME**

ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT

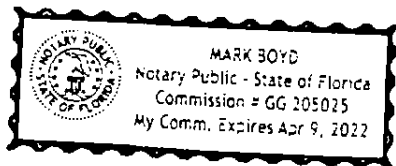

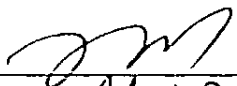

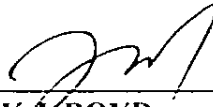
